Application is hereby made for temporary use of a Weir River Water System (WRWS) fire hydrant to supply water solely for the purpose indicated and approve on this application. The Applicant agrees to abide by the Rules and Regulations of the WRWS now in force, and operating procedures as outlined below. All applications must include a deposit check of four thousand dollars (\$4,000.00) payable to the "Weir River Water System" and submitted to the WRWS at 25 Bare Cove Park Drive, Hingham, MA 02042. The Applicant will be responsible for all costs, fees, and water usage until removal of the temporary meter and a final meter reading is obtain. The WRWS may inspect the backflow device and/or change the water meter with reasonable notice as may be required.

2. Moving the hydrant set up without written approval of WRWS is prohibited;
3. Only WRWS personal are approved to attached the meter set up to the fire hydrant;
4. Only WRWS are allowed to operate any water system assets including the fire hydrant and branch valve;
5. Once opened the contractor is to utilize the provide gate valve to adjust flow;
6. The hydrant must ALWAYS remain in the full open position while in operation;
7. Contractor must supply the necessary hoses and adapters to connect to the water meter;
